SONOC Company, LLC, a Delaware limited liability company ("SONOC"), assigned to Developer all of SONOC's rights as "Developer" under the Declaration, pursuant to that certain Assignment of Developer's Rights recorded in Official Records Book 3343, Page 1171 of the public records of St. Johns County, Florida.
- C. Pursuant to Developer's right to amend as set forth in Section 11.6 of the Declaration, the undersigned hereby amend the Declaration as more particularly set forth herein.

NOW THEREFORE, the parties hereby amend the Declaration as follows:

- 1. <u>Sidewalks</u>. A new Section 8.31 is hereby added to the Declaration as follows:
- "Sidewalks. Any Owner of a Lot developing a Residential Dwelling Unit on such Lot shall construct any sidewalk on or in front of such Lot, in accordance with the subdivision construction plans submitted to and approved by St. Johns County. Such sidewalk shall be completed prior to the issuance of a certificate of occupancy for such Lot."
- 2. **Ratification**. As specifically amended hereby, all of the terms and provisions of the Declaration shall remain in full force and effect.
